# O konvenciji “ONA JE TU”

Prva regionalna Konvencija žena Zapadnog Balkana pod nazivom "Ona je tu", održaće se od 25. do 27. maja u Podgorici, u novoj zgradi Glavnog grada, u saradnji sa Glavnim gradom Podgorica, Crnogorskim narodnim pozorištem, uz podršku Ministarstva nauke u Vladi Crne Gore, kao i brojnih organizacija, kompanija, institucija i medijskih kuća koje su prepoznale važnost ovakvog događaja za jačanje vladavine prava u našem regionu.

"Ona je tu" je odgovor žena sa prostora Zapadnog Balkana na izazove i dileme sa kojima se sve žene i danas susrejeću, na svim dijelovima planete. Razvojni put Zapadnog Balkana u demokratski društveno-politički kontekst jeste i razvojni put žene sa prostora Zapadnog Balkana u osnaženu, samosvesnu ženu sa inicijativom.

Konvencija ima za cilj da otvari neke od ključnih tema kojima se danas bave žene širom planete, a po kojima nisu dovoljno prepoznate, ili su u potpunosti nevidljive, posebno u našem regionu. Tri ključne oblasti koje će biti zastupljene na ovogodišnjoj konvenciji usmjerene su na: ulogu žene u jačanju ključnih prioriteta vladavine prava, ženu i razvoj preduzetništva i ženu i stvaralaštvo.

Prihvatajući sva temeljna načela Univerzalne deklaracije o ljudskim pravima, pa zatim UN Konvencije o eliminisanju svih oblika diskriminacije žena (CEDAW), žena je prvi put prepoznata kao faktor mira, ključna akterka mirovnih pregovora Rezolucijom SB UN 1325 tek 2000. godine, kada su zemlje u regionu, između ostalih i Crna Gora, ovu rezoluciju i usvojile. Rezolucija svojim obimom, od Vlada širom planete, između ostalog, zahtijeva kreiranje uslova za podsticajno poslovno okruženje za žensko preduzetništvo, jednak tretman žena i muškaraca na radnom mjestu, suzbijanje diskriminatorskih praksi na svim nivoima i povećanje broja žena na svim mjestima odlučivanja.

Kako nam je pored društveno-političkog aktivizma i profesionalnog razvoja, inspiracija, kreativnost i motivacija žene veoma važna, poseban dio Konvencije biće posvećen ulozi žene u svijetu kulture i umjetnosti, a biće organizovane i uvodne radionice na temu ličnog razvoja.

S obzirom da duboko vjerujemo da ravnopravnost polova u tradicionalnim društvenim kontekstima nikada neće biti moguća ni ostvariva kroz borbu, već naprotiv, kroz saradnju i inkluziju, posebno ćemo se truditi da naša Konvencija bude primjer ravnopravnosti i zajedničkog djelovanja kroz nediskriminatorski pristup vrijednovanju životne priče žene ili muškarca bilo gdje na svijetu.

# About The Convention “She Is Here”

The first Regional Convention of Women, entitled "She is here", will be held in Podgorica from 25-27th May in partnership with the City of Podgorica, Montenegrin National Theatre and with the support of the Ministry of Science in the Government of Montenegro.

"She is here" is an initiative of women, from different professions in Montenegro and Serbia, who have gathered a team of established female professionals and academics in order to give a more concrete support to the visibility and larger involvement of women in all areas of public life of Western Balkans. This said, we are not dependent on any donorstrategies, but are completely focused on assisting women from all areas in improving their professional, activist and private lives.

"She is here" is dedicated to women from the entire region, with a special focus on three main areas: role of women in strengthening the rule of law, women in entrepreneurship and personal and professional development of women.

Apart from the advocating for important institutional changes, such as the passing of the NAP for the implementation of the UN SC R 1325 Women, Peace and Security which would cover the key areas from women agenda, this 3-day convention will be comprised of discussions and practical workshops from the area of career development, entrepreneurship, social-political activism, human rights, psychology, art, literature, etc., nearly 200 attendees from civil, business and public sector will have a chance to be inspired for their further work on the strengthening of society as a whole. Our guests and speakers on the convention will be relevant names from all areas of public life, from Western Balkans, EU and entire world.

Bearing in mind that we as organizers deeply believe that gender equality can be reached only through inclusion, not exclusion, this initiative is aiming to gather both men and women from Western Balkans to address the issues of concern as equals.

Završila je *United World College* u Trstu, diplomirala na Pravnom fakultetu u Podgorici, magistrirala je na Kyushu univerzitetu u Japanu kao stipendista japanske vlade, dok je zvanje doktora nauka stekla na Pravnom fakultetu, Univerziteta Crne Gore. Dr Spaić je nacionalna korespondentkinja UNCITRAL-a, arbitarka Međunarodnog arbitražnog suda pri Privrednoj komori CG i posrednik Centra za medijaciju. Članica je Centra za mlade naučnike Crnogorske akademije nauka i umjetnosti, kao laureatkinja, i članica *Global Young Academy*. Pre-davačica je na različitim forumima iz oblasti poslovnog i medijskog prava. Koautorka je nekoliko monografija i pisac značajnog broja članaka u naučnim, stručnim međunarodnim i domaćim časopisima.

is Associate Professor at the University of Montenegro, teaching several courses at the Law Faculty and Faculty of Political Sciences. She graduated from the United World College in Trieste, as well as from the Law Faculty in Podgorica. She obtained her Masters degree in Law at the Kyushu University as a Japanese Government scholar, and subsequently obtained her Ph.D. at the Law Faculty at the University of Montenegro. She is a national correspondent to UNCITRAL, arbiter of The International Court of Arbitration with the Chamber of Commerce, and a mediator for the Centre for Mediation. She is a member of the Center for Young Scientists of the Montenegrin Academy of Science and Art as the laureate, and a member of the Global Youth Academy. She has given lectures/speeches on business and media laws. She is a co-author of several monographs, as well as an author of a significant number of articles in scientific, specialized international and national journals.





## Emina Kolarević

Diplomirala je Međunarodne odnose na Univerzitetu John Cabot u Italiji. Postdiplomske studije Međunarodnog prava završila je na Westminster Univerzitetu u Londonu, dok je magistrirala na zajedničkom programu Univerziteta u Bolonji i Univerziteta u Sarajevu, demokratija i ljudska prava (ERMA). Pripravnički staž odradila je u Kancelariji predstavnika Crne Gore pred Evropskim sudom za ljudska prava, tokom kojeg je učestvovala u pripremi pravne odbrane države za predstavke koje su u fazi glavne rasprave pred Evropskim sudom, sa fokusom na primjeni Konvencije o ljudskim pravima i sudske prakse Evropskog suda. Rad u oblasti ljudskih prava nastavila je u organizacijama civilnog društva, Institutu za javnu politiku u Beogradu, pa Komitetu pravnika

za ljudska prava (YUCOM), gdje je učestvovala u istraživanju i implementaciji projekata iz oblasti vladavine prava, zaštite prava vulnerablenih grupa, rodne ravnopravnosti, jednakih prava u obrazovanju, klijentelizma u medijima. Kao istraživač radila je u Share fondaciji na projektu zaštite podataka o ličnosti u javnom sektoru Srbije. ## Florence Hartmann

novinarka i spisateljica, započela je karijeru u francuskim dnevnim novinama *Le Monde* za koje je pokrivala pad Jugoslavije i ratove koji su uslijedili.

1999. godine u Francuskoj objavljuje političku biografiju Slobodana Miloševića - Milošević, la diagonale du fou (Milošević: Dijagonalna laufera) (Denoël/Gallimard) u kojoj otkriva na koji je način beogradski silnik bio umiješan u rat i zločine koji su se dogodili u zemljama koje su u susjedstvu Srbije. 2000. napušta pariški *Le Monde* da bi postala portparolka glavnog tužiteljke Haškog tribunala i savjetnica za Balkan tokom mandata Karla Del Ponte. 2007. godine vraća se novinarstvu i pisanju, objavljuje drugu knjigu o sukobu između međunarodne pravde i međunarodne politike, pod nazivom *Mir i kazna* (Paix et Châtiment) (Flammarion). 2015. je napisala knjigu o zapadnim silama i genocidu u Srebrenici pod (*Le Sang de la Realpolitik : l'Affaire Srebrenica* (Don Quichotte, Paris) - Krv realpolitike : Afera Srebrenica, (Buybook, Sarajevo)). 2014. godine je potpisala knjigu o uzbunjivačima (*Les Lanceurs d'alerte, les mauvaises consciences de nos démocraties*, Don Quichotte, Paris / Uzbunjivači, Profil, Zagreb). Česta je govorica na konferencijama na kojima je tema Balkan, tranzicija pravda, ljudska prava i procesi demokratizacije. Od 2008. godine je član izvršnog odbora Fonda za humanitarno pravo, beogradske NGO koja se bavi dokumentovanjem ratnih zločina i tranzicione pravde. Dobitnica je nekoliko nagrada za ljudska prava i 2014. godine je postala jedna od malobrojnih strankinja koje su proglašene počasnim građankama Grada Sarajeva.

A journalist and an author, Florence Hartmann started her carriers at the French daily *Le Monde* for which she covered the fall of Yugoslavia and the subsequent wars. In 1999, she published in France a political biography of Slobodan Milosevic, *Milosevic, la diagonale du fou* (Denöel/Gallimard) in which she revealed how Belgrade strong man was involved in the war and the crimes committed in Serbia's neighbouring countries. In 2000, she left *Le Monde* in Paris to become the ICTY/ICTR chief prosecutor's spokesperson and Balkan advisor under the mandate of Carla Del Ponte. In 2007 after returning to journalism and writing, she published a second book on the rivalry between international justice and international politics, entitled *Paix et Châtiment* (Flammarion). She also authored in 2015, a book on Western powers and the genocide in Srebrenica (*Le Sang de la Realpolitik : l'Affaire Srebrenica* (Don Quichotte, Paris) - Krv realpolitike : Afera Srebrenica, (Buybook, Sarajevo)). In 2014, she signed a book about Whistleblowers (*Les Lanceurs d'alerte, les mauvaises consciences de nos démocraties*, Don Quichotte, Paris / Uzbunjivači, Profil, Zagreb). She is often a conference speaker on issue pertaining to the Balkans, transitional justice, human rights and democratisation processes. Since 2008, she is a member of the Humanitarian Law Centre executive board, a Belgrade based NGO dealing with war crimes documentation and transitional justice. She has been awarded with several human rights prizes and became in 2014 one of the few foreign women who received the honorary citizenship of the City of Sarajevo.

## Dr Gordana Đurović

Osnivačica i direktorka Centra za kulturnu dekontaminaciju, Pavillon Veljković u Beogradu (od 1994). Pisala je kolumnne u Susretu, zatim nedjeljniku Vrijeme, od njegovog osnivanja i u dnevnom listu Danas. Objavila je dvije zbirke eseja - «Na ex - Postdejtonska moda» (Novi Pazar, 1998.) i «Moda» (Beograd, 1994.); – kao i brojne tekstove u časopisima, dnevnim i nedjeljnim novinama. Dramaturgist, Theater "Atelier 212," Belgrade (10 years) and BITEF, Belgrade's annual international festival of avant-garde theater (20 years). Dramaturgist in Zenica, Split, Skopje, Ljubljana, Subotica and Belgrade (1978-1991). Founder, "New Sensibility" theater at old Belgrade brewery (1981). Participated in artistic movement "KPGT;" acronym for the word "theater" in Croatia, Serbia, Montenegro, Slovenia and Macedonia (1984-1991). Artistic director, Belgrade Drama Theater, removed after public and political statements (1993). A member of Belgrade Circle, organization of independent intellectuals. Founder and director of Center for Cultural Decontamination, Veljković Pavilion, Belgrade (1994-present). Regular columnist in Sustret, in Vreme weekly and, currently, in Danas. Published works include two collections of essays, At X: Post-Dayton Fashion (Novi Pazar, 1998) and Fashion (Belgrade, 1994); "Do you remember?" in The Other Serbia (Belgrade, 1992); and many articles in newspapers, magazines and journals. Since 1991 she participated in different anti-war actions in Belgrade and various Yugoslav cities and in several Yugoslav organizations aimed for the democratization and development of the civil society in Serbia and in the region (after the year of 1992 - former Yugoslavia). She was one of the signers of the Declaration of The Civil Resistance.

## Dr Shirin Ebadi

je jedna od prvih sutkinja u Iranu, a služila je i kao prva predsjednica jednog od najviših sudova u zemlji dok nije razriješena dužnosti 1979. godine od strane Islamske revolucije. 1990. Ebadi se vratila pravu kao zaštitnica prava žena i djece, osnivajući Centar za ljudska prava koji je predvodio pravnu reofrmu i javnu raspravu u vezi sa diskriminacijskim zakonima Islamske republike. Branila je mnoge najistaknutije zatvorenike savjesti u ovoj zemlji i provela je skoro mjesec dana u zatvoru 1999. zbog svog rada. Dugi niz godina je bila centar iranskog samoniklog ženskog pokreta. 2003. godine je dobila Nobelovu nagradu za mir za svoj rad.

was one of Iran's first female judges and served as the first female chief magistrate of one of the country's highest courts until the 1979 Islamic Revolution stripped her of her judgeship. In the 1990s Ebadi returned to the law as a defender of women's and children's rights, founding a human rights centre that spearheaded legal reform and public debate around the Islamic Republic's discriminatory laws. She has defended many of the country's most prominent prisoners of conscience and spent nearly a month in prison in 1999 for her activities. For many years she was at the center of the Iran's grassroots women's movement. In 2003 she was awarded the Nobel Peace Prize for her work.

## Slavoljub Stijepović

je rođen u Titogradu 2. maja 1959. Godine. Završio Pravni fakultet i položio pravosudni ispit. Od marta 1991. do decembra 1996. godine – pomoćnik ministra rada i socijalnog staranja. Od jula 2001. do januara 2003. godine – sekretar Republičkog sekretarijata za sport. Od januara 2003. do novembra 2006. godine – ministar rada i socijalnog staranja. Od novembra 2006. do oktobra 2007. godine – potpredsjednik Ustavotvorne Skupštine Crne Gore. Od oktobra 2007. do juna 2009. godine – potpredsjednik Skupštine Crne Gore. Od juna 2009. do aprila 2010. godine – ministar bez portfelja u Vladi Crne Gore. Od aprila 2010. do

decembra 2010. godine – ministar prosvjete i nauke. Od decembra 2010. do decembra 2012. godine – ministar prosvjete i sportsa. Od decembra 2012. godine – ministar prosvjete. Za gradonačelnika Podgorice izabran je 6. oktobra 2014. godine.

was born on May 2, 1959 in Podgorica, and graduated in law from the University of Podgorica. He joined the DPS early in his career, and after a stint as Legal Advisor for the construction firm "Provborac" in Herceg Novi, he has been Assistant Minister of Labor and Social Welfare (1991-1996), Minister without Portfolio (1996-1998), Minister of Sports (1998-2001), Minister of Labor and Social Welfare (2003-2006), and Deputy Speaker of Parliament (2006-2009). Stijepović has also been President of the Montenegrin Football Association and Chairman of the Podgorica Fund for Physical Culture.

## Samra Čampara

Šefica medijskog programa Misije OEBS u Crnoj Gori. U misiji OEBS-a za Crnu Goru je od septembra 2015. godine. Takođe je bila šefica Medijskog odeljenja u OEBS misiji na Kosovu. Trenutno je izvršna direktorka Mreže za rodna pitanja Centralne i Istočne Evrope (CEE Network for Gender Issues). Ona je takođe jedna od inicijatorki Pakta za stabilnost i predsjedavajuća Radne grupe za jednakost polova.

is a well-known Slovenian politician from the era of the former country: Lokar was the MP elected in the first multi-party national elections in Slovenia from 1990 to 1992. She published over 300 articles in Slovenian, Croatian, English, French and German. She was active as a researcher and political analyst. She is currently the executive director of the CEE Network for Gender Issues. She is also one of the initiators of the Stability Pact and president of the Task Force for Gender Equality.

## Gordana Subotić

Takodje, Gordana je osnivačica ženskog Udruženja Dea Dia gdje je kordinirala praćenje primjene Rezolucije 1325, istraživanje i edukacije o lokalizaciji primjene Rezolucije 1325. Prema mnogim Vedraninim knjigama napravljene su pozorišne predstave koje su igrale u Londonu, Budimpešti, Beogradu, Zagrebu, Santa Monici (California). Knjiga "Dabogda te majka rodila" prevedena je na nekoliko jezika, a adaptirana je i za pozorište u Rijeci, gradu u kome Vedrana Rudan živi. Knjiga govori o vječnoj temi, o mržnji i ljubavi između majke i kćeri. Autorica je u Hrvatskoj poznata i kao vrlo čitana blogerica. Njen blog "Kako umrijeti bez stresa" ima više od 160.000 fanova, a pogledan je više od 10 miliona puta. In the meantime, she wrote about ten books which have been translated to a dozen languages. Three of her books were published in Poland: Uho, grlo, nož (Ear, throat, knife), Ljubav na posljednji pogled (Love at last sight) and Crnci u Firenci (Black men in Firenze). Based on the book Uho, grlo, nož Krystyna Janda wrote a monodrama which she has been performing in her theatre for the past ten years. Many of Vedrana's books were made into theatre plays performed in London, Budapest, Belgrade, Zagreb, Santa Monica (California). Her book Dabogda te majka rodila has been translated into several languages, and it was adapted for theatre in Rijeka, the city where Vedrana Rudan lives. The book talks about the eternal topic of hatred between a mother and daughter. The author is famous in Croatia as a very popular blogger. Her blog Kako umrijeti bez stresa (How to die without stress) has over 160,000 fans and 10 million hits. Vedrana's latest book Jesi li svršio, dragi (Have you finished, dear) will be come out in the end of June in Belgrade. Her stories have been published in the most prestigious American collections of stories and literary magazines.
